### **Principal Research Interests**

Formal semantics and its connections with syntax, pragmatics, logic; related issues in philosophy of language and in cognitive science. Recent past: research on cross-linguistic quantification and more generally on issues of universality and typology in semantics; research on interaction of topic-focus structure, quantification-relevant structure, and various aspects of context-dependence in semantic interpretation; cooperative research with colleagues in Prague aimed at integrating Hajičová and Sgall's contemporary Prague school approach with work in formal semantics; cooperative research with Hans Kamp on foundational issues concerning context-dependence in semantics; research on interaction of noun phrase semantics with verbal aspect; collaborative research with Russian colleagues aimed at integration of Russian lexical semantics (and some western lexical semantics) with formal semantics, sortal structures and sort-shifting, interface of lexical and compositional semantics. NSF grant 1999- 2003 with V. Borschev on the integration of formal and lexical semantics and the semantics of genitives. NSF grant 2004-08 with V. Borschev on Genitive of Negation in Russian and the integration of formal and lexical semantics. Philosophical interests include the relation between model-theoretic and psychologicistic approaches to the foundations of semantics; and more generally on various logic-oriented and linguistics-oriented approaches to issues in natural language semantics and problems of compositionality. Currently working on a book project on the history of formal semantics for Oxford University Press.
